Fraud Alert Form

Place a fraud alert on your credit files by making a **single** call to **one** of the fraud assistance numbers listed below. The credit agency that you call will share the information with the other two companies. The fraud alert will remain in place for approximately three months. **You must make a written request to the companies in order for the alert to remain in place for several years.** See the sample letters.

**If you will call Experian,(Automated) when the voice begins giving options, follow these prompts for faster service. Press #2(All Others), next prompt Press #3(Reason To Believe Fraud) and the last prompt Press #2(All Others). Once you reach this part you will be asked for your Social Security number, your zip code and the numerical address of your residence. If accepted, you will be given a Confirmation Number, write this down for future reference.*

A complimentary copy of your credit report will be sent to you when a fraud alert is placed on your credit file, with a maximum of one report per year from each company.
